- (5) One letter of recommendation (high school seniors only) - from a Counselor **OR** a Teacher;
- (6) All forms (application, copy of FAFSA Submission Summary, transcript, letter of recommendation) must be **received** by the Trustees by **May 1 (be careful of mail time!)**;
- (7) All commitments are subject to full acceptance by the Trustees. Scholarship recipients and high school counselors will be notified by letter or email by May 31, 2024.
